Dear All

as you certainly know we have to deliver the EUDET 2007 Annual Report to Brussels tomorrow. Unfortunately I have not received a single bit of information yet concerning the CNRS financial form C and the justifications (Appendix 1). As already announced this means that CNRS will appear with 0 everywhere in the report, including the new implementation plan, to be sent tomorrow. In other words, you will not be able to profit from the next instalment.

**We are thus again in the same situation we had already last year. You should be aware that all other EUDET partners will suffer from your failure to comply to the contract as the next instalment will again be delayed. Needless to say that this situation is unacceptable, serious and needs to be changed urgently.**

In order to pre-warn you and to give you some time to get prepared I want to let you know that I'm going to call for an **exceptional (phone) meeting of the EUDET Institution Board**.

The proposed day is March 14. At this meeting I want to discuss and decide on measures to improve the situation in future, or at least to avoid negative consequences for all other 22 partners by late instalments. In particular I want to invite CNRS representatives to present measures you want to take to avoid such problems in future. After repeating the bad experience from last year it is evident to me (and probably many others) that your internal structure and management is inadequate and needs to be changed. In parallel I shall discuss other options with members of the consortium.

**Subject: Initial information on the outcome of the evaluation of proposals.**

The Commission services with the help of independent experts have recently evaluated the proposals submitted in the context of the above-mentioned call. This includes the proposal entitled: “**DevDet**”, for which you are the coordinator.

Your proposal was evaluated against the criteria published for the call. The attached evaluation summary report (ESR) records the views of the expert evaluators and the scores that your proposal achieved.

Based on this evaluation by independent experts, the Commission services will rank in priority order those proposals that passed all the evaluation thresholds, and will then take a decision on the lists of proposals for which negotiations of the grant agreement can proceed. This letter does not prejudice the outcome of this process.

This letter does not constitute an offer of funding for your proposal.

For information, in this particular call, it is estimated that funds will be available to support around 40 projects out of the 125 that have passed all evaluation thresholds.
